

KNOWLEDGEWORX LEARNING MANAGEMENT SYSTEM LICENSE AGREEMENT

PLEASE READ THIS ONLINE END USER LICENSE AGREEMENT (“AGREEMENT”) CAREFULLY BEFORE USING ANY OF THE ONLINE TRAINING SERVICES OFFERED BY KNOWLEDGEWORX (“Knowledgeworx”) DESCRIBED BELOW. BY USING THE SERVICES, YOU ACKNOWLEDGE THAT YOU READ AND UNDERSTAND THIS AGREEMENT AND AGREE TO BE BOUND BY ITS TERMS.

3. **Payment.** For access to and use of the Services, you agree to pay the amounts set forth in Appendix 1 of the Sales Development Agreement for the number of users for which you are purchasing a license. You hereby acknowledge and agree that the subscription fee is payable in advance and in full for each user license purchased upon acceptance of this Agreement and you will be charged whether you use the Services or not.
4. **Restrictions On Use.** All pages within the Learning Management System (LMS) and any material made available for download (collectively the Website”) are the property of Knowledgeworx and/or its affiliates. The Website is protected by federal and international copyright and trademark laws and no portion of the materials on these pages may be reprinted, republished, modified, or distributed in any form without the express prior written permission of Knowledgeworx. Access to the Website may not be shared with any third party. 12. Exclusive Remedy. Your sole right and exclusive remedy for breach of this Agreement by Knowledgeworx if you are dissatisfied for any reason with the Services is to terminate this Agreement as provided in the Sales Development Agreement.
13. Subscriber and renewal fees are nonrefundable. Pro-rated fees or credits will not be issued upon cancellation of subscription by subscriber, even if cancellation occurs prior to anniversary date. Subscriber may terminate this Agreement upon Knowledgeworx's failure to cure an ongoing, material breach of this Agreement within thirty (30) days after giving Knowledgeworx written notice of such material breach. Knowledgeworx may at any time and without advance notice modify or restrict your use of the Services, or terminate this Agreement if Knowledgeworx determines, in its sole discretion, that your use of the Services: (i) violates Knowledgeworx's Terms of Use; (ii) violates any laws, regulations, court orders, or other governmental request or order which requires immediate action; (iii) violates any intellectual property rights of Knowledgeworx or a third party; (iv) violates any export or import regulations; (v) is disruptive or causes a malfunction of the Services; (vi) may expose Knowledgeworx to potential legal liability; or (vii) if you fail to timely pay any amounts required under this Agreement; (viii) a license is being used by other than the named licensee.
14. Rights and Duties Upon Termination. Upon termination of this Agreement, all rights to the Services terminate immediately. You remain liable for the full charge(s) for all unexpired Term(s) as defined in the Sales Development Agreement. If this Agreement is terminated for any reason, you agree not to re-register for or otherwise access the Services without Knowledgeworx's prior written approval. Knowledgeworx may delete any data files associated with your use of the Services upon termination of this Agreement.
15. General Terms. Your rights and obligations under this Agreement may not be assigned or transferred without the written permission of Knowledgeworx and any assignment or transfer in violation of this provision shall be null and void. If any provision of this Agreement is determined to be invalid, all other provisions will remain in force. Notice or other communication between you, and Knowledgeworx may be given by conventional first-class mail or by email. Notices sent by first-class mail are effective on the fifth day after mailing.
